Construction: During production, safe, odorless, and durable inks are used, providing deep color saturation. The wall clock is made of 4mm thick glass. The edges of the glass are trapezoidally and matte polished. Each clock is equipped with a hanger mounted on the clock mechanism and foam spacers that ensure an even distance between the clock and the wall.

Package Contents:

- 1 x Wall clock
- 1 x Installation instructions

The entire clock is protected with bubble wrap (BK) or PE foam, and then packed in a cardboard box, dedicated exclusively to ARTTOR glass-faced clocks. Additionally, model AC has all corners protected with plastic covers to provide maximum protection.

Cleaning and Maintenance of the Clock:

Regularly check the condition of the mountings and hooks to ensure the clock is securely hung.

If the clock requires cleaning, use only a soft, dry cloth to avoid damaging its surface. Avoid using rough or sharp materials. To clean the clock face thoroughly, it is recommended to first remove the battery from the mechanism and then gently remove the hands by lifting them from the spindle to allow free access to the entire clock face. Wipe gently in one direction, avoiding circular motions. After cleaning, reassemble the hands by positioning them at 12 o'clock, and then set the current time by turning the knob on the mechanism clockwise. Finally, reinsert the battery into the mechanism.



Attention, use the product according to its intended purpose. The product is not a toy and may contain small, protruding parts. Keep away from children.




The product is battery-powered. 1x AA battery. Battery not included with the product.

Installation Instructions (EN)

Before proceeding with installation, carefully read the instructions below. If you have any questions or doubts, contact the manufacturer to ensure safe and correct installation.

Safety Measures:

- Always wear protective gloves to protect your hands during installation.
- Wear safety glasses to protect your eyes from possible splinters
- Ensure that the installation site is safe, technically verified, and structurally sound. Take care to avoid damaging any technical infrastructure within the wall (e.g., plumbing or electrical systems).
- The manufacturer is not responsible for the choice of installation site or for any damage caused during installation work.
- The clock should only be hung on the designated hanger. The manufacturer is not responsible for other mounting methods, such as strings or adhesive tapes. The responsibility for using non-standard solutions lies with the installer.
- Do not use sharp tools to avoid damaging the product.

Unpacking the Product:

- Carefully open the carton by removing the staples in designated places.
- Gently slide out the contents and place them on a stable, dry surface.
- Remove the protective foam and adhesive tape and gently take out the contents from the branded packaging.
- Carefully remove all protective elements from the product.
- Thoroughly check the clock to ensure it is free from damage or defects. If you notice any issues, contact the supplier before proceeding with installation.
- If the product has plastic corner protectors, leave them on during installation to avoid damaging the edges.
- After unpacking, place the clock in a safe spot until you are ready to hang it.

Important! After removing the clock hands' protective covers, which are wrapped in stretch tape, check their alignment and ensure they are parallel to the clock face. If the hands are slightly bent, gently straighten them to ensure proper function.

Tool Preparation:

Prepare a screwdriver, measuring tape, pencil, screws, hook, and other chosen mounting systems. The manufacturer recommends using hooks as the safest option for mounting.

Choosing a Location:

Select a suitable location on the wall, ensuring that it is well-lit and visible. Check that the wall material is strong enough to support the clock's weight (weight is provided in the product description).

Preparing the Wall Surface:

The wall surface should be dry, clean, and smooth. Ensure there are no contaminants or chips that could affect the stability of the installation.

Marking the Location:

Determine the appropriate installation height (usually at eye level) and mark the spot on the wall where the hook will be installed.


Drilling and Installing the Screw or Hook:

Following safety recommendations and installation guidelines, drill a hole in the designated spot and install the hook. The manufacturer is not responsible for poorly executed installation work, so ensure careful and precise installation.

Clock Installation:

The clock is equipped with a mounted hanger, making it easy and safe to hang on the pre-prepared hook. Ensure that the hook is securely fastened and properly selected for the weight of the clock. Before mounting, insert an AA-LR6 battery into the mechanism and set the current time. If the clock has plastic corner protectors, remove them only after hanging the clock on the wall.

Attention: Ensure that the clock is mounted parallel to the wall. Proper installation ensures stability and aesthetic appearance. The clock should not protrude or tilt from the wall surface.



Responsibility for Installation:

The person performing the installation should have the necessary knowledge and skills to handle tools. Installation is carried out at the installer's own risk. In case of inexperience, it is recommended to consult a competent person for safe installation of the clock.

Remember to always follow the manufacturer's recommendations and adhere to the guidelines to ensure safe and durable installation of the product.
